# What is VET (Vocational Education and Training)?

Vocational Education and Training (VET) refers to enhanced senior school studies, which enables a secondary student to combine their **Victorian Certificate of Education** (VCE), **Victorian Certificate of Education Vocational Major** (VCE-VM) or **Victorian Pathways Certificate** (VPC) studies with vocational training.

VET assists VCE and VCE VM students in making the transition to further education, training and employment through the development of work-related competencies, skills and knowledge in a particular industry. VET programs allow students to gain the VCE or VCE VM and a Certificate II, III or IV qualification in areas of specific interest.

Padua College offers senior secondary students VET qualifications selected from a range of industry areas. Students can choose from over 40 different courses in all areas of interest. Some courses are delivered onsite at Padua College or off-site by other Registered Training Organisations. Classes typically run on Wednesday or Friday complimenting the VCE VM and VPC programs.

VET opens many future career opportunities in areas with increasing employment demands. For example, VET offers nationally recognised qualifications that create pathways to over 500 careers in a diverse range of industries including Health, Technology, Engineering, Food, Science, Construction, and IT. The practical nature of VET allows you to develop valuable skills and knowledge and gives you the opportunity to apply them in the workplace. VET also develops your employability skills. By selecting a VET subject, it can make a valuable contribution to your education and your future.

Please note that courses offered are subject to sufficient class numbers. Additional fees and costs are applicable to all VET subjects whether held on campus or at an external provider. The school does not provide transport to the external training provider. Students need to make their own transport arrangements. ## How does it work?

VET programs are delivered at Padua College, Chisholm TAFE and at some of the other partner schools or Register Training Providers (RTO). Classroom training is combined with practical and simulated experiences, and Structured Workplace Learning (SWL) in the industry.

## How does VET contribute to the ATAR /VCE/ VCE VM and VPC?

Direct credit towards the Australian Tertiary Admission Rank (ATAR): selected VCE VET programs are offered as scored assessment (study scores) for Units 3 & 4 in the same way all VCE studies and include an end-of-year examination and study score.

Block Credit towards the ATAR: a contribution of 10% of the lowest subject score as a fifth or sixth subject Credits towards the VCE VM and VPC: 180 nominal hours' worth of completed units of competency from a Certificate II qualification or higher will provide two credits towards a VCE VM or VPC program.

# How do students apply?

Students who are interested in undertaking a VET program will be provided with information on courses and guidance at the Careers and Pathway Interviews. Students will then select the relevant VET course when completing their online subject selection and will also need to register for the course by completing and returning an application form and a non-refundable deposit by the due date.

Please note:

- All VET programs incur additional costs
- Most programs are subsidised by the Melbourne Archdiocese Catholic Schools, however there are no additional discounts for Health Care Cards or "Free TAFE" programs
- Students need to make their own travel arrangements to and from the external VET location
- Courses are dependent on numbers and may be oversubscribed or cancelled due to low demand
- Students may miss Padua College timetabled classes. Some classes may extend beyond normal school hours.

# Certificate III in Acting (Screen)

## Course Code 22576VIC

This course is designed for students who are passionate about this specialised subject and intend to pursue an acting career. It provides skills and knowledge in a broad range of foundation and intermediate acting tasks relating to film and television, to enhance employment prospects as performers in film and television.

VET Acting is delivered to Years 10, 11, 12 students and includes:

- Filming in front of a camera / Film production
- Confidence and communication building
- Preparation and presentation for interviewing, auditioning and screen-testing
- Digital skills development relevant to industry
- Development and application of creative arts industry knowledge
- Development of performance skills and script knowledge
- Acting technique development

### Contribution to VCE/VCE-VM

On completion of the program students are eligible for four credits towards their VCE, two at Unit 1&2 and a Unit 3&4 sequence. Students who successfully complete the Unit 3&4 sequence will be eligible for a 10% increment towards their ATAR. VTAC may award students who receive a Unit 3&4 sequence through Block Credit recognition, 10% of their fourth subject.

# Certificate II in Agriculture

## Course Code AHC20116

Certificate II in Agriculture is an introductory course that prepares students for work in the Agriculture industry. The course aims to provide students with knowledge and skills in a range of basic agricultural practices, including aspects of plant production.

### Contribution to VCE/VCE-VM

On successful completion of the program: recognition of two (2) or more units at Units 1&2 level and a Unit 3&4 sequence. Students who successfully complete the Unit 3&4 sequence will be eligible for an increment as their fifth or sixth subject towards their ATAR. This is not a scored Program (there are no examinations).

# Certificate II in Animal Care

## Course Code ACM20121

The aim of the course is to provide the basic skills and knowledge to become an animal carer. You will learn how to care for a variety of animals and provide information on companion animals, products and services. Gain the practical skills and basic knowledge needed for entry level work in the animal care and management industry where workers provide care for animals in workplaces such as animal shelters, boarding/daycare facilities, and vet clinics. Learn how to assist with general animal care, provide food and water for animals and follow OH&S procedures in the workplace. Students will work with guinea pigs, rabbits, fish and reptiles, and other animals as available.

### Contribution to VCE/VCE-VM

This is not a VET scored assessment. Credit in the VCE (including VCE VM and VPC): recognition of up to three VCE VET units at Units 1 and 2 level, and a VCE VET Unit 3&4 sequence.

### Types of Assessment

Practical assessments and written assessments including work to be completed at home between classes.

12 units of competency - 7 core units and 5 electives

# Certificate II in Applied Fashion & Textiles

## Course Code MST20722

This course provides an introductory overview of skills applied in the fashion industry. It includes skills used in the design and production of garments and millinery, as well as in the development of unique fashion and textile designs used in Indigenous Australian culture. The aim of the course is to provide students with the skills and knowledge to achieve competencies that will enhance their employment prospects in the textiles, clothing and footwear industry and to enable students to make a more informed choice regarding further education and career paths.

### Contribution to VCE/VCE-VM

Credit in the VCE (including VCE VM and VPC): recognition of up to five VCE VET units at Units 1 and 2 level, and a VCE VET Unit 3&4 sequence. On completion of the program, students are eligible for five credits towards their VCE, three at Unit 1 & 2 level and a Unit 3 &4 sequence. Students who successfully complete the Unit 3&4 sequence will be eligible for a 10% increment toward their ATAR.

### Types of Assessment

Written assessment and practical assessment – using a sewing machine, making a simple garment. Students will be required to purchase a folio and sewing kit. At least four garments will be expected to be made per year with material purchased by students.

# Certificate II in Automotive Vocational Preparation

## Course Code AUR20720

This qualification reflects the role of individuals who perform a limited range of tasks relating to identifying and inspecting mechanical and electrical components and systems of light vehicles, heavy vehicles, outdoor power equipment, bicycles, marine craft and motorcycles. This qualification also covers the skills and knowledge required to perform minor maintenance and repair of an automotive vehicle body. The range of technical skills and knowledge is limited. This course is designed to introduce students to the theory and practice of automotive maintenance and repair in a hands-on learning environment and focuses on providing students with stimulated practical work experience, employability skills and career pathways into the automotive industry as an apprentice.

### Contribution to VCE/VCE-VM

Students undertaking AUR20720 Certificate II in Automotive Vocational Preparation (Release 1) are eligible for up to four VCE VET units on their VCE (including VCE VM and VPC) statement of results:

- Two VCE VET units at Units 1&2 level
- A VCE VET Unit 3&4 sequence

# Certificate III in Aviation (Remote Pilot)

## Course Code AVI30419

Remote pilots operating at this level will apply non-technical and technical knowledge and skills to demonstrate autonomy and judgment and will take limited responsibility within established regulatory parameters. Individuals will learn to operate remotely piloted aircraft (drones) within visual line of sight below 400 feet outside of controlled airspace, greater than three nautical miles from an aerodrome, outside of populous areas. Students will also complete the requirements for certification by the Civil Aviation Safety Regulation (CASR).

### Contribution to VCE/VCE-VM

On completion of the program students are eligible for four credits towards their VCE, two at Units 1-2 and a Unit 3-4 sequence.

Students who successfully complete the Unit 3-4 sequence will be eligible for a 10% increment towards their ATAR.

#### Question of students directly

- Pop quizzes throughout the online training material
- Questions from the study guide for students
- Exercises during the practical component of flight training
- Sample problems and scenarios during the practical component of flight training
- At end of the theory a final examination will be taken

# Certificate III in Beauty Services

## Course Code SHB30121

This qualification reflects the role of individuals employed as beauticians to provide a range of beauty services including nail, waxing, lash and brow, and basic make-up services.

These individuals possess a range of well-developed technical and customer service skills where discretion and judgment are required and are responsible for their own outputs. This includes client consultation on beauty products and services.

Work is typically conducted in beauty, waxing, brow and nail salons.

### Contribution to VCE/VCE-VM

Credit in the VCE or VCAL: recognition of up to four VCE VET units at Units 1&2 level, and a VCE VET Units 3&4 sequence.

This program will provide students with the knowledge and skills to enhance their employment prospects in the building and construction industry as an apprentice. The course consists of a core of common cross sector units of competency that provide skills and knowledge in applying basic leveling procedures, carrying out basic measurements and calculations, communicating in the workplace, erecting and safely using working platforms, interpreting basic plans and drawings, preparing and applying for work in the construction industry, working effectively and sustainably in the construction industry and workplace safety practices onsite. The course also includes a range of units that introduce the learner to the application of specific materials, tools and equipment, and techniques used in specific trade sectors. On successful completion of this course, students will have achieved the pre-apprenticeship certificate. Students will be required to attend training to obtain the Construction Induction Card (known as a White Card) undertaken at Padua College.

### Contribution to VCE/VCE-VM

Credit in the VCE or VCE VM: recognition of up to four VCE VET units at Units 1 and 2 level, and a VCE VET Units 3&4 sequence.

Written assessment and practical assessment. The VCE VET Building & Construction program does not offer scored assessment.

This qualification reflects the role of individuals in a variety of Business Services job roles. It is likely that these individuals are establishing their own work performance. This course provides students with the opportunity to develop a broad range of skills and knowledge to work in a variety of work contexts using discretion, judgement and relevant theoretical knowledge. Individuals in these roles carry out a range of routine procedural, clerical, administrative or operational tasks that require technology and business skills. They apply a broad range of competencies using some discretion, judgment and relevant theoretical knowledge. They may provide technical advice and support to a team.

### Contribution to VCE/VCE-VM

Credit in the VCE (including VCE VM and VPC): recognition of up to two VCE VET units at Units 1&2 VCE VET units at Unit 1&2 Level, a scored VCE VET Unit 3-4 sequence and an additional non-scored VCE VET Unit 3-4 sequence. The scored Unit 3&4 sequence must be delivered and assessed in a single enrolment year. Students are strongly advised against undertaking the scored Unit 3&4 sequence without first completing Units 1&2 because Unit 3&4 sequences are not designed for standalone study.

# Certificate II in Computer Assembly and Repair

## Course Code UEE20520

This qualification provides competencies to select components and assemble computer to customer specifications and carry out routine hardware repairs (generally by replacement) of known faulty components following prescribed routines. This course is designed to introduce students to the theory and practice of selecting components and assembling computers to customer specifications and carrying out routine hardware repairs.

Credit in the VCE or VCE VM recognition of up to four VCE VET units at Units 1 and 2 level, and a VCE VET Units 3 and 4 sequence.

# Certificate II in Cookery

## Course Code SIT20421

The qualification is designed to support employees who perform a range of tasks in hospitality establishments, from food preparation and cookery skills to the creation of food and menu items. This qualification provides a pathway to work in kitchen operations in organisations such as restaurants, hotels, catering operations, clubs, pubs, cafés, and coffee shops; and institutions such as aged care facilities, hospitals, prisons, and schools. The course includes units such as preparing appetisers and salads; preparing stocks, soups and sauces; preparing vegetable, fruit and farinaceous dishes; preparing poultry. The qualification does not meet the requirements for a trade recognition as a cook.

### Contribution to VCE/VCE-VM

Credit in the VCE (including VCE VM and VPC), recognition of up to two VCE VET units at Units 1&2 level, and a scored VCE VET Unit 3&4 sequence. Students wishing to receive an ATAR contribution must undertake scored assessment for the purpose of achieving a study score. This study score can contribute directly to the primary four or as a fifth or sixth subject.

Units 3 and 4 offer scored assessment and include units such as recording and mixing a basic music demo, operating sound reinforcement systems and installing and disassembling audio equipment.

This pre-apprenticeship course is designed to introduce students to the basic theory and practice of plumbing in order to prepare them to enter the plumbing industry or a plumbing and gas-fitting apprenticeship at the Certificate III level. This course provides a consistent outcome for students with basic skills that allows for employment across all streams of plumbing. The course consists of 19 compulsory units of competency that provide skills and knowledge in workplace safety practices on site, workplace communication, carrying out measurements and calculations, reading and producing technical drawings, applying basic sheet metal practices, using various welding equipment, and using plumbing tools and resources. This course does not meet the requirements for a registered plumber.

Students cannot use this qualification until they are 18 years of age or older. You must also complete a short Language Literacy and Numeracy (LLN) test to be enrolled.

Salons may also be part of larger chains, often operating as franchises.

Employment opportunities reflect roles such as ceramics studio assistant, community theatre assistant, and arts, craft, or design practitioner. It applies to work in different visual arts, crafts, and design environments. Practice at this level is underpinned by the application of introductory art theory and history.

The job roles that relate to this qualification may include Ceramics Studio Assistant, Community Theatre Assistant, and Arts, Craft or Design Practitioner. It also provides pathways to other visual arts, craft, and design job roles. Individuals may work under direction, using some discretion and judgment, and may provide support to a team. They may also work autonomously on familiar tasks within defined work settings.
