



APPLICATION FOR EMPLOYMENT – EDUCATION SUPPORT POSITION

Any false or incomplete statement or information in this form or in connection with your application for employment may lead to a rejection of your application for employment. Any information provided by you in this form may be checked by the prospective employer with relevant authorities, previous employers, referees or sources. By signing or submitting this form you consent to these pre-employment checks. Information provided will be treated in accordance with the *Privacy Act 1988* (Cth).
